The signed proxy form with the securities agent's seal on the sign-in card will serve as the sign-in card for the proxy to represent the shareholder's vote at the meeting. If the shareholder or the proxy did not receive the sign-in card one day prior to the meeting, please bring the identification card and seal to the venue on the day of the meeting for attendance.
